## **GENERAL**

The V-9934 is a Remote Microphone for use with the V-9933A, Noise Sensing Volume Control.

## **SPECIFICATIONS**

### **Purpose**

The V-9934 provides remote noise sensing for the V-9933A.

### **Features**

- Self-contained microphone and pre-amp
- Phantom powered; no power supply required
- Screw terminal connections
- Up to four units may be paralleled on one V-9933A
- Each V-9934 may be on a 1000' wire run
- Uses CAT3/5/5e/6 twisted pair telephone cable (One pair)

### **Mounting**

The V-9934 is designed for wall mounting. When mounting this unit in a noisy area, make sure that the front is not obstructed in any way. It should be mounted in the noisy area 12-15 feet high. Care should be taken not to mount the V-9934 directly adjacent to any noise sources such as HVAC blowers, ceiling fans, conveyors, etc.

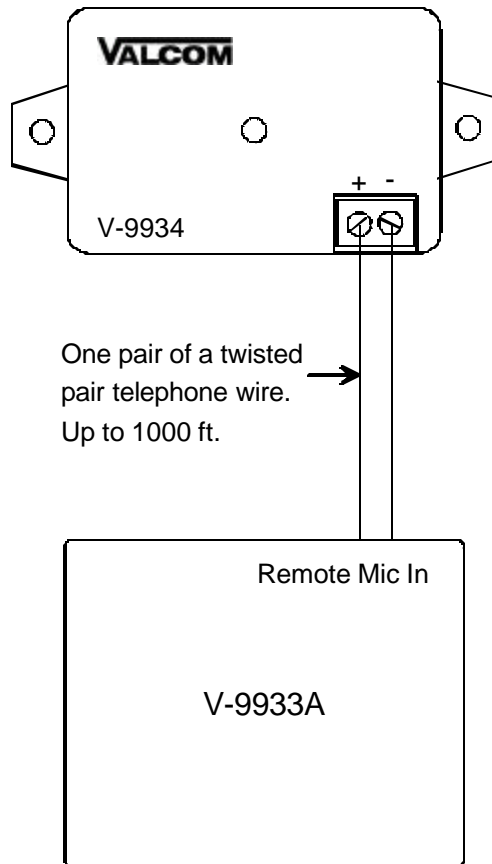
When trouble is reported, verify connections to the V-9933A.

5. all units 'out of warranty' are subject to a service charge. The service charge will cover minor repairs (Major repairs will be subject to additional charges for parts and labor).

**This warranty is in lieu of and excludes all other warranties, expressed or implied, and in no event shall Valcom, Inc. be liable for any anticipated profits, consequential damages, loss of time or other losses incurred by the buyer in connection with the purchase, operation or use of the product.**

This warranty specifically excludes damage incurred in shipment. In the event a product is received in damaged condition, the carrier should be notified immediately. Claims for such damage should be filed with the carrier involved in accordance with the F.O.B. point.
